2. The above appointee will be entitled to draw dearness and other allowances at the rates admissible and subject to the conditions laid down in the rules and orders governing grant of such allowances in force from time to time.

3. The terms and conditions of this appointment shall be as under:-

- i) The post is temporary, but likely to become as permanent one.
